

Boost your donation by 25p of Gift Aid for every £1 you donate

Gift Aid is reclaimed by the charity from the tax you pay for the current tax year.

Dear Member

Gift Aid is a government scheme that allows charities like Kelso Heritage Society to claim back basic tax rate on donations. Your Membership payment qualifies as a donation. This means that as long as you are a UK taxpayer we can claim back at least an extra £2.00 of your membership fee at no cost to yourself. This valuable income will help us go forward with our plans to promote the historic environment of our town

In order to enable us to claim back the appropriate tax we should be grateful if you would complete the form below even if you do not qualify or wish to give your consent. You will only be required to complete the form once. The information is for the sole use of Kelso Heritage Society and will only be used in the process of reclaiming tax.

Consent to Gift Aid (at no extra cost)

Gift Aid is worth .25p for every £1 you donate

Gift Aid is reclaimed by the charity from the tax you pay for the current year

We can treat the individual element of your membership as a donation and reclaim the tax you have already paid on it

You only have to consent once to allow us to claim Gift Aid

I wish Kelso Heritage Society to treat any eligible donations or membership subscriptions as Gift Aid donations.

I can confirm I am a UK taxpayer and understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all my membership subscription/donations in that tax year it is my responsibility to pay any difference.
